### 5:00 Orton Academy Principal's Report – Cindy Kanuch

- Enrollment Update
  - Exciting things are happening, Enrollment number = 90 students, tonight is the first information night of the Spring, Dan Snowberger has spoken with ALLIES and offered 6th graders another school to attend, possibly two 6th grade classes for next year (large numbers, 24 students), 6-8 tours per week.
- Attendance Update
  - Have not been able to get them from Synergy (93% for January)
  - o Tardies 6% Same students ever time

- Marketing Update
  - o 2 representatives at the Parents Challenge choice fair
  - Marketing meeting will be at March 6th after school in person

# • STEM Day

- o Cindy has a colleague who runs Ascend College Prep
- o Students attended last Friday to run STEM activities.
- o Possibly after school club in the future

#### • Data

- Can't measure according to other school standards of testing
- Orton calculates what percentage of benchmark scored
- Average growth Middle of the year testing is long, students have anxiety
- Cindy does an overview of STAR Math, Not far off of the benchmark for certain grades,
- STAR Reading, Writing Rubric, DIBELS DORF (connect to text passage that is at grade level, 3 components to the test)
- Anna asks about data that shows students who have been in the Orton program (full dosage of intervention)
- Why is 7th grade so low? Could be a combination of new students and summer slide, Cindy will review data
- Cindy is impressed with the growth, Students may not know phonics patterns yet, Cindy has happy with 20% grow based on MOY benchmarks
- Take Flight has a progress monitoring system, DIBELS DORF is the best test available, Cindy gives background of DIBELS (Acadiance)
- DIBELS DAZE fluency and accuracy (grade level passage)
- Anne Cindy will identify 2 or 3 goals in reading and will share with the board
- Bruce had an issue with the denominator switching on assessing data
